#### LITERATURE REVIEW

Historical Context of Electoral Misinformation

Bennett & Livingston (2018) in "The Disinformation Order" analyze how digital platforms have transformed the information ecosystem, creating what they term "computational propaganda." In the Indian electoral context, Pal & Gonawela (2017) document how WhatsApp and social media platforms became vectors for electoral misinformation during the 2014 and 2017 state elections.

The Election Commission's response through innovations like the cVIGIL app represents what Howard & Bradshaw (2019) categorize as "institutional adaptation" to

digital challenges. Their research on "Challenging Truth and Trust" shows how electoral management bodies globally are developing technological solutions to counter misinformation.

Philosophical Foundations of Truth in Governance

Ancient Indian texts have consistently emphasized truth (Satya) as the foundation of good governance. The Mahabharata's principle "Dharmo rakshati rakshitah" (righteousness protects those who protect it) resonates with modern concepts of institutional integrity. Radhakrishnan (1953) in "Indian Philosophy" demonstrates how these principles form an unbroken intellectual tradition supporting transparent governance.

Contemporary scholars like Sen (2005) in "The Argumentative Indian" show how India's philosophical heritage provides robust frameworks for democratic discourse based on evidence and rational argumentation rather than propaganda and manipulation.

#### International Best Practices

James (2020) in "Comparative Electoral Management" analyzes how election commissions worldwide are developing counter-misinformation strategies. The Brazilian Superior Electoral Court's fact-checking partnerships and Australia's electoral commission's public education campaigns offer models that the ECI has adapted to Indian conditions.

Norris (2014) in "Why Electoral Integrity Matters" provides empirical evidence that public trust in electoral institutions correlates strongly with the perceived independence and transparency of election management bodies.
